After paying inspection fees Fire Brigade Department will renew the Final No Objection Certificate. It is the duty of the Developer / Architect to inform the Occupier / Residence. In failure of fulfilling the requirement of Fire Department, the owner / Architect / occupier will be personally responsible.

The Chief Fire Officer Reserves right to amend any additional recommendations deemed fit during the stage wise inspection due to statutory provision amended from time to time and in the interest of the protection of the building / People.

The Party has paid the capitation fees of Rs. 7,86,781/- for the gross built up area 23841.84 Sq. Mtr. as per mentioned in the provisional N. O. C. (Ref. No. 3). This N. O. C. is issued for the total 12535.00 Sq. Mtr. as per letter given by the architect. Dated : 03/10/2023.
